SUBJECT: **Payment Due Dates and Price Announcement Dates for 2007**

Enclosed with this letter is a Payment Due Date schedule and a Price Announcement Dates schedule. The Payment Due Date schedule identifies the due dates for funds payable to the Market Administrator, Advance and Final Payments to Producers, and Advance and Final Payments to Cooperatives. Please note that in order for a payment to be considered timely the payment must be received by the respective party by the close of business on the date specified. Section 1126.71, .72, .73 states that payment must be received on or before the due date to be considered timely. Any payment that is received after the date specified will be considered late and will be subject to a 1 percent late charge, as set forth in §1000.78. Payment is to be paid by the method authorized by the payee (i.e., wire transfer, cash, check, etc.) and to the appropriate authorized location (i.e., bank lock box, bank account, address of payee, etc.).

The schedule of Price Announcement Dates for the year 2007 specifies the dates on which the Advanced Prices and Pricing Factors and the Class and Component Prices will be announced during the upcoming year. This schedule along with the price announcements is located on the United States Department of Agriculture, Dairy Programs website and can be accessed through the internet at the following address:

The advance pricing factors will be released on the Friday before the 23rd of the preceding month unless this date is a Friday. Likewise, the class and component prices will be released on the Friday before the 5th of the following month unless this date is a Friday. The release time for all release dates, except Nov. 23, is 10:00 a.m. EST/EDST; for Nov. 23, the release time is 2:00 p.m. EST.
