### **USDA RECONVENES NATIONAL PUBLIC HEARING ON PROPOSED AMENDMENTS TO ALL FEDERAL MILK ORDERS**

Washington, D.C., March 20, 2007 – The U.S. Department of Agriculture today announced that it will reconvene a national public hearing to consider proposals seeking to amend the Class III and Class IV product price formulas applicable to all Federal milk marketing orders. The hearing will begin at 1:00 p.m. on April 9 at the Radisson Hotel City Centre Indianapolis, 31 West Ohio Street, Indianapolis, Ind. 46204, telephone (317) 635-2000.

The public hearing was originally held Feb. 26 – March 2 in Strongsville, Ohio. The purpose of reconvening this proceeding is to receive additional testimony on proposed amendments 1 through 20 as published in the original hearing notice on Feb. 9, 2007, and the supplemental notice of hearing on Feb. 20, 2007, in the Federal Register.
