

MARKET SUMMARY FOR MAY

The Producer Price Differential (P.P.D.) for milk delivered to handlers located in Dallas/Tarrant counties (TX) of the Southwest Milk Market Order was \$1.33 for May. Butterfat price decreased \$0.1489 per pound from \$1.6964 in April to the level of \$1.5475 in May. Protein price decreased \$0.1090 per pound from \$2.7055 in April to \$2.5965 in May. May's Other Solids price increased \$0.0023 per pound from \$0.1020 in April to \$0.1043 in May. The Somatic Cell Count adjustment rate factor for May was .00074 per thousand (difference from 350).

For comparison in hundredweights, producers who delivered milk to handlers located in Dallas/Tarrant counties (TX) received a May statistical uniform price of \$15.10 per hundredweight for milk testing 3.5% butterfat, 2.99% true protein, 5.69% other solids and 350,000 SCC. This is a decrease of \$0.18 in comparison to the statistical blend price of \$15.28 in April.

The May Class I price increased \$0.67 from \$17.13 in April to the May level of \$17.80. The Class II price for May of \$12.78 per hundredweight decreased \$0.46 from \$13.24 in April. May's Class III price decreased \$0.84 from \$14.61 in April to \$13.77 in May. The Class IV price decreased \$0.41 from \$12.61 in April to \$12.20 in May.


In May 819 producers delivered a total of 845,899,071 pounds of milk. On a daily basis this represents an increase of 14.47 percent from the producer receipts level in April and it represents an increase of 25.88 percent when compared to the producer receipts level of May 2004.

Producer milk classified as Class I during May amounted to 39.73 percent of total producer receipts. This figure is down from 49.00 percent in April and it is down from 47.27 percent in May 2004. The average butterfat test of producer milk pooled during May was 3.565 percent, average protein test was 2.987 percent, average other solids test was 5.725 percent and the average somatic cell count was 269,000.






