

MARKET SUMMARY FOR JULY

The Producer Price Differential (P.P.D.) for milk delivered to handlers located in Dallas/Tarrant counties (TX) of the Southwest Milk Market Order was \$1.80 for July. Butterfat price decreased \$0.0106 per pound from \$1.2544 in June to the level of \$1.2438 in July. Protein price decreased \$0.0313 per pound from \$1.7283 in June to \$1.6970 in July. July's Other Solids price increased \$0.0226 per pound from \$0.0723 in June to \$0.0949 in July. The Somatic Cell Count adjustment rate factor for July was 0.00057 per thousand (difference from 350).

For comparison in hundredweights, producers who delivered milk to handlers located in Dallas/Tarrant counties (TX) received a July statistical uniform price of \$11.77 per hundredweight for milk testing 3.5% butterfat, 2.99% true protein, 5.69% other solids and 350,000 SCC. This is an increase of \$0.13 in comparison to the statistical uniform price of \$11.64 in June.

The July Class I price increased \$0.18 from \$13.08 in June to the July level of \$13.26. The Class II price for July of \$10.87 per hundredweight increased \$0.08 from \$10.79 in June. July's Class III price remained unchanged at \$9.97 the same as the June price. The Class IV price decreased \$0.07 from \$10.22 in June to \$10.15 in July.

In June 520 producers delivered a total of 948,169,733 pounds of milk. On a daily basis this represents a decrease of 7.57 percent from the producer receipts level in June and it represents a decrease of 8.33 percent when compared to the producer receipts level of July 2008.

Producer milk classified as Class I during July amounted to 35.30 percent of total producer receipts. This figure is up from 32.91 percent in June and it is up from 31.35 percent in July 2008. The average butterfat test of producer milk pooled during July was 3.445 percent, average protein test was 2.932 percent, average other solids test was 5.740 percent and the average somatic cell count was 253,000.

AGRICULTURE SECRETARY ANNOUNCES RELIEF FOR DAIRY PRODUCERS

Agriculture Secretary Vilsack has announced that the Obama Administration is taking immediate action to support struggling dairy farmers by increasing the amount paid for dairy products through the Dairy Product Price Support Program (DPPSP). USDA estimates show that these increases, which will be in place from August 2009 through October 2009, will increase dairy farmers' revenue by \$243 million.

"The Obama Administration is committed to pursuing all options to help dairy producers," said Vilsack. "The price increase announced today will provide immediate relief to dairy farmers around the country and keep many on the farm while they weather one of the worst dairy crises in decades."

The increase announced today will raise the price paid for nonfat dry milk from \$0.80 per pound to \$0.92 per pound, the price paid for cheddar blocks from \$1.13 per pound to \$1.31 per pound, and the price of cheddar barrels from \$1.10 per pound to \$1.28 per pound. This increase in the support price will have an immediate effect upon dairy farmers' bottom line. Temporarily raising the price of these dairy products increases the price that dairy farmers receive for their milk.

USDA estimates that today's announcement is expected to increase the all milk price received by dairy producers. The increase will result in the government purchase of an additional 150 million pounds of non-fat dry milk (NDM) and an additional 75 million pounds of cheese.

Prior to this announcement, USDA had taken several steps to provide support for dairy farmers, including the following:

- In March, USDA transferred approximately 200 million pounds of nonfat dry milk to USDA's Food and Nutrition Service, which will not only remove inventory from the market, but also support low-income families struggling to put nutritious food on their tables.
- USDA expects to spend more than \$1 billion in fiscal year 2009 on purchases of dairy products (Dairy Product Price Support Program) and payments to producers (Milk Income Loss Contract (MILC).
- On March 22, 2009, USDA reactivated USDA's Dairy Export Incentive Program (DEIP), to help U.S. dairy exporters meet prevailing world prices in addition to encouraging the development of international export markets in areas where U.S. dairy products are not competitive due to subsidized dairy products from other countries.
- Since March 22, USDA has encouraged the export of 20,000 tons of nonfat dry milk.
 - From July 2008 through June 30, 2009, DEIP

has announced allocations of 68,201 metric tons of nonfat dry milk; 21,097 metric tons of butterfat; 3,030 metric tons of various cheeses and 34 metric tons of other dairy products.

- USDA is working with the Department of State to identify foreign assistance programs such as U.S. Agency for International Development (USAID) and McGovern-Dole International Food for Education and Child Nutrition Program to make the following available:
- At least 1 million pounds on a competitive basis, for the production of casein;
- About 500,000 pounds for use in the McGovern-Dole International Food for Education and Child Nutrition Program; and
- About 1 million pounds for use by the U.S. Agency for International Development, based on anticipated requests from the State Department.
 - USDA is currently reviewing federal dairy policy

THIRD CWT HERD RETIREMENT IN NINE MONTHS: SECOND-LARGEST EVER

Cooperatives Working Together (CWT) has announced that it has tentatively accepted 294 bids in the third herd retirement it has conducted in the last nine months. The 86,710 cows and 1.8 billion pounds of milk accepted in this round, combined with CWT's previous two herd retirements, equal a total production capacity of 4.8 billion pounds of milk being removed since December 2008.

This is the second-largest herd retirement since the farmer-funded self-help program started in 2003. The previous retirement round completed in July removed a record 101,000 cows and 1.96 billion pounds of milk.

"These two summer 2009 herd retirements, combined with the USDA's recent price support increases, should result in very positive movement in dairy farmers' milk prices," said Jerry Kozak, President and CEO of NMPF, which administers CWT.

Farmers in 38 states submitted a total of 312 herd retirement bids last month to CWT. This eighth CWT herd retirement in the past six years was also the first to feature a maximum acceptable bid threshold of \$5.25 per cwt. It was also the quickest herd retirement following a previous round, which is an indication "that there is still an interest on the part of our members to use CWT to remove more cows, even though the program has been very active in 2008 and to date in 2009," noted Kozak.

Kozak said that "CWT stands ready to conduct yet additional herd retirements later this year in order to help address the severe supply-demand imbalance that has depressed farm-level milk prices. We intend to use all the resources at our disposal to help farmers deal with this severe economic crunch that they're confronting," he said.




