

MARKET SUMMARY FOR OCTOBER

The Producer Price Differential (P.P.D.) for milk delivered to handlers located in Dallas/Tarrant counties (TX) of the Southwest Milk Market Order was \$1.82 for October. Butterfat price decreased \$0.2413 per pound from \$2.2005 in September to the level of \$1.9592 in October. Protein price decreased \$0.1071 per pound from \$3.0282 in September to \$2.9211 in October. October's Other Solids price increased \$0.0233 per pound from \$0.4053 in September to \$0.4286 in October. The Somatic Cell Count adjustment rate factor for October was 0.00087 per thousand (difference from 350).

For comparison in hundredweights, producers who delivered milk to handlers located in Dallas/Tarrant counties (TX) received a October statistical uniform price of \$19.85 per hundredweight for milk testing 3.5% butterfat, 2.99% true protein, 5.69% other solids and 350,000 SCC. This is a decrease of \$1.81 in comparison to the statistical uniform price of \$21.66 in September.

The October Class I price decreased \$2.22 from \$24.78 in September to the October level of \$22.56. The Class II price for October of \$19.41 per hundred-weight decreased \$1.14 from \$20.55 in September. October's Class III price decreased \$1.04 from \$19.07 in September to \$18.03 in October. The Class IV price decreased \$1.12 from \$19.53 in September to \$18.41 in October.

In October 500 producers delivered a total of 973,939,983 pounds of milk. On a daily basis this represents a decrease of 0.67 percent from the producer receipts level in September but it represents an increase of 4.38 percent when compared to the producer receipts level of October 2010.

Producer milk classified as Class I during October amounted to 38.72 percent of total producer receipts. This figure is down from 38.97 percent in September and it is down from 40.62 percent in October 2010. The average butterfat test of producer milk pooled during October was 3.661 percent, average protein test was 3.195 percent, average other solids test was 5.730 percent and the average somatic cell count was 200.000.

USDA ANNOUNCES NATIONAL DAIRY BOARD IMPORTER APPOINTMENTS

Agriculture Secretary Tom Vilsack has announced the appointment of two dairy importer members to the National Dairy Promotion and Research Board.

"Importer representation on the board will enhance participation in the development of promotion, research, and nutrition education programs to expand the demand for dairy products and dairy ingredients," said Secretary Vilsack.

Newly appointed members include Kenneth E. Meyers who will serve a three-year term ending Oct. 31, 2014 and Giovanna Vita who will serve a two-year term ending Oct. 31, 2013.

The board was established under the Dairy Production Stabilization Act of 1983, as amended, to develop and administer a coordinated program of promotion, research, and nutrition education. The 38-member board is authorized to design programs to strengthen the dairy industry's position in domestic and foreign markets. The program is financed by a mandatory 15-cent per hundredweight assessment on all milk marketed commercially and a 7.5-cent per hundredweight assessment, or equivalent thereof, on milk and dairy products imported into the United States.

The Secretary selected the appointees from nominations submitted by individual importers of dairy products or by organizations representing dairy importers. USDA's Agricultural Marketing Service monitors the operation of the board.

OCTOBER AGRICULTURAL PRICES HIGHLIGHTS


The All Milk price received by farmers was \$19.90 in October, down \$1.20 from September 2011 and up \$1.40 from October 2010. Milk Cows price was \$1,480 in October, up \$150 from October 2010. Alfalfa hay price was \$203.00 in October, up \$85.00 from October 2010. Corn price was \$5.92 in October, up \$1.60 from October 2010. Soybean price was \$11.90 in October, up \$1.70 from October 2010. The milk-feed

price ratio was 1.79 in October, down 0.61 from October 2010.

The index of prices received by farmers for dairy products decreased 10 points during the month of October 2011 to 152. Compared with October 2010, the index was up 10 points (7.0 percent). The index of prices paid by farmers for commodities and services, interest, taxes, and wage rates in October 2011 was unchanged at 205 from the previous month. Compared with October 2010, the index was up 20 points (10.8 percent).

SEPTEMBER 2011 DAIRY PRODUCTS HIGHLIGHTS

BUTTER production was 137.6 million pounds, 21.0 percent above September 2010 and 3.5 percent above August 2011. AMERICAN TYPE CHEESE production totaled 337.0 million pounds, 4.2 percent below September 2010 and 3.2 percent below August 2011. TOTAL CHEESE output (excluding cottage cheese) was 867.3 million pounds, 0.6 percent below September 2010 and 0.2 percent below August 2011. NON-FAT DRY MILK production, for human food, totaled 103.9 million pounds, 5.0 percent below September 2010 and 9.6 percent below August 2011. DRY WHEY production, for human food, was 69.6 million pounds, 7.5 percent below September 2010 and 2.7 percent below August 2011. ICE CREAM (hard) production totaled 67.2 million gallons, 6.5 percent below September 2010 and 13.2 percent below August 2011.




