

MID-AMERICA DAIRYMEN INC. ORDERED TO SELL BORDEN/MEADOW GOLD DAIRIES

Mid-America Dairymen Inc. (Mid-Am) the largest dairy cooperative in the United States—will be allowed to acquire Borden/Meadow Gold Dairies Holdings Inc. as long as Mid-Am sells Borden dairies in Texas, Louisiana and New Mexico to another competitor, under a settlement filed September 3 by the Department of Justice. A newly-formed firm, Milk Products LLC, will be allowed to buy the divested dairies under certain conditions set out in the proposed settlement.

The Department's Antitrust Division said that if Mid-Am's acquisition of Borden had gone forward as originally proposed, it would have reduced competition for the sale of milk to public schools throughout eastern Texas and virtually all of Louisiana. A total of nine plants will be sold—five in Texas, three in Louisiana and one in New Mexico.

"Recently, we have rooted out and prosecuted many cases of criminal collusion in the sale of milk to schools, which resulted in higher prices for schools," said Joel I. Klein, Assistant Attorney General in charge of the Department's Antitrust Division. "It is important that we act to prevent mergers or acquisitions that might have the same effect."

Schools that participate in the U.S. Department of Agriculture's national school lunch and breakfast programs are required to offer fluid milk with every meal. The schools usually seek bids from the dairy firms that operate delivery routes in their area on an annual basis. Throughout much of Texas and Louisiana, Southern Foods Group LP, in which Mid-Am has a partial ownership interest, and Borden are the only two bidders for school milk contracts.

The transaction as originally proposed would have included the spin-off of Borden's Texas and Louisiana operations to Milk Products, which is expected to be based in Dallas, with Mid-Am financing most of the purchase price.

The complaint alleges that the original remedy was inadequate because the loan would have left Mid-Am with the ability to influence the operations of Milk Products. Combined with its partial ownership of Southern Foods, the loan would have given Mid-Am the incentive and ability to limit

competition between the two dairy firms.

The settlement will maintain competition by requiring Mid-Am to divest the Borden dairy operations located in Texas, Louisiana, and New Mexico and by placing limits on the terms and duration of any loans to Milk Products. The settlement also requires Mid-Am to reduce any loans to zero by September 1, 1999, and places strict limits on Mid-Am's access to information about Milk Products.

Borden/Meadow Gold, headquartered in Ogden, Utah, has 25 dairy processing plants in the western half of the U.S., including eight located in Texas and Louisiana. Southern Foods Group LP is headquartered in Dallas.

As required by the Tunney Act, the proposed consent decree will be published in the Federal Register. Any person may submit written comments concerning the proposed decree during a 60-day comment period to Roger W. Fones, Chief, Transportation, Energy and Agriculture Section, Antitrust Division, U.S. Department of Justice, 325 7th Street, N.W., Suite 500, Washington, D.C. 20530 (202/307-6351).

At the conclusion of the 60-day comment period, the U.S. District Court in Dallas may enter the consent decree upon a finding that it serves the public interest.

DAIRYMAN AND DRIVERS SENTENCED FOR ADULTERATION OF MILK

Former AMPI driver Daniel Jay Burtch is the latest to be sentenced for conspiring to participate in a scheme to sell milk which contained water that had been purposely added. Burtch was sentenced to five years probation in U.S. District Court in Fort Worth on September 9. In addition, Mr. Burtch was ordered to pay \$82,251.50 restitution for his part in the scheme to add water to milk.

Earlier in August two other individuals were also sentenced for fraud that involved watering down milk. Tommy Wayne Davis, a dairyman, of Yantis was sentenced to six months in prison without parole. Truman Leon Pope Sr., a milk-truck driver, of Sulphur Springs was sentenced to a year and a day without parole.

MARKET SUMMARIES FOR AUGUST

The August Class III price increased \$1.21 from the previous month to \$12.07. The Class II price for August of \$11.04 per hundredweight increased 4 cents from \$11.00 in July. August's Class III-A price decreased 18 cents from July's level to \$11.88.

Texas: Producers who delivered milk to handlers located in Zones 1 and 2 of the Texas Milk Market Order received \$13.03 per hundredweight for deliveries of milk containing 3.5% butterfat. The August price was up 30 cents from July.

Producers delivered a total of 442,182,567 pounds of milk during August. On a daily basis this represents a decrease of 2.39 percent from the producer receipts level in July and it represents a decrease of 5.57 percent when compared to the producer receipts level of August 1996.

Producer milk classified as Class I during August amounted to 62.07 percent of total producer receipts. This figure is up from July's 57.44 percent but it is down slightly


from 62.92 percent in August 1996. The average butterfat test of producer milk pooled during August 1997 was 3.400 percent.

New Mexico - West Texas: Producers who delivered milk to handlers located in Zone 1 of the New Mexico - West Texas Milk Market Order received \$12.42 per hundredweight for deliveries of milk containing 3.5% butterfat. The August price was up 70 cents from its July level.

Producers delivered a total of 168,990,992 pounds of milk during August. On a daily basis this represents a decrease of 10.59 percent from the producer receipts level in July and it represents a decrease of 18.00 percent when compared to the producer receipts level of August 1996.

Producer milk classified as Class I during August amounted to 32.15 percent of total producer receipts. This figure is up from 27.75 percent in July and it is up from 29.12 percent in August 1996. The average butterfat test of producer milk pooled during August 1997 was 3.378 percent.




