MARKET SUMMARIES FOR DECEMBER

The December Class III price increased 33 cents from the previous month to \$13.29. The Class II price for December of \$13.13 per hundredweight increased 4 cents from \$13.09 in November. December's Class III-A price decreased \$1.55 from November's level to \$12.46.

Texas: Producers who delivered milk to handlers located in Zones 1 and 2 of the Texas Milk Market Order received \$14.80 per hundredweight for deliveries of milk containing 3.5% butterfat. The December price was up 10 cents from November.

Producers delivered a total of 504,713,380 pounds of milk during December. On a daily basis this represents an increase of .64 percent from the producer receipts level in November but it represents a decrease of 3.64 percent when compared to the producer receipts level of December 1996.

Producer milk classified as Class I during December amounted to 53.42 percent of total producer receipts. This figure is virtually unchanged from November's 53.59 percent but it is up from 50.70 percent in December 1996. The average butterfat test of producer milk pooled during December 1997 was 3.792 percent.

New Mexico - West Texas: Producers who delivered milk to handlers located in Zone 1 of the New Mexico - West Texas Milk Market Order received \$13.81 per hundredweight for deliveries of milk containing 3.5% butterfat. The December price was up 8 cents from its November level.

Producers delivered a total of 185,487,739 pounds of milk during December. On a daily basis this represents an increase of 9.96 percent from the producer receipts level in November but it represents a decrease of 16.50 percent when compared to the producer receipts level of December 1996.

Producer milk classified as Class I during Decem-

ber amounted to 29.23 percent of total producer receipts. This figure is down from 31.58 percent in November but it is up from 23.91 percent in December 1996. The average butterfat test of producer milk pooled during December 1997 was 3.770 percent.

1998 SUPPORT PRICES FOR MILK AND MILK PRODUCTS

The U.S. Department of Agriculture's Commodity Credit Corporation (CCC) announced that the support price for milk will be \$10.05 per hundredweight (cwt) during calendar year 1998, effective January 1, 1998. This is a reduction of 15 cents per cwt from the current support level, and is required by the Federal Agriculture Improvement and Reform Act of 1996 (the Act). The Act authorized the Milk Price Support Program through December 31, 1999, at the following support price levels: \$10.35 per cwt during calendar year 1996, \$10.20 per cwt during calendar year 1997, \$10.05 per cwt during calendar year 1998, and \$9.90 per cwt during calendar year 1999.

This announced price is for milk with an annual butterfat content of 3.67 percent. In order to carry out the new support level, CCC will decrease the price it pays for nonfat dry milk by 1.9 cents per pound to \$1.0280 and decrease the price for block Cheddar and barrel cheese by 1.5 cents per pound to \$1.1150 and \$1.0850 per pound, respectively. The purchase price for butter will remain at \$0.6500 per pound. The support price adjusted to a butterfat content of 3.5 percent by use of the Federal Milk Marketing Order butterfat differential formula is \$9.95 per cwt.

There are currently no uncommitted CCC inventories of butter, cheese, or nonfat dry milk. If the government does acquire such inventories, CCC may sell any commodity owned or controlled by the Corporation at any price the Secretary determines will maximize the return to the Corporation.




