

#### MARKET SUMMARIES FOR SEPTEMBER

The September Class III price increased 11 cents from the previous month to \$15.10. The Class II price for September of \$15.07 per hundredweight increased \$1.67 from \$13.40 in August. September's Class III-A price increased \$3.29 from August's level to \$19.81.

**Texas:** Producers who delivered milk to handlers located in Zones 1 and 2 of the Texas Milk Market Order received \$16.81 per hundredweight for deliveries of milk containing 3.5% butterfat. The September price was up \$1.31 from August.

Producers delivered a total of 489,660,484 pounds of milk during September. On a daily basis this represents an increase of 32.74 percent from the producer receipts level in August and it represents an increase of 23.21 percent when compared to the producer receipts level of September 1997.

Producer milk classified as Class I during September amounted to 55.05 percent of total producer receipts. This figure is down from August's 72.11 percent and it is down from 69.31 percent in September 1997. The average butterfat test of producer milk pooled during September 1998 was 3.47 percent.

New Mexico - West Texas: Producers who delivered milk to handlers located in Zone 1 of the New Mexico - West Texas Milk Market Order received \$16.09 per hundredweight for deliveries of milk containing 3.5% butterfat. The September price was up \$1.04 from its August level.

Producers delivered a total of 115,013,414 pounds of milk during September. On a daily basis this represents an increase of 10.81 percent from the producer receipts level in August and it represents an increase of .13 percent when compared to the producer receipts level of September 1997.

Producer milk classified as Class I during September amounted to 46.83 percent of total producer receipts. This figure is down from 50.12 percent in

August and it is down from 49.46 percent in September 1997. The average butterfat test of producer milk pooled during September 1998 was 3.40 percent.


#### **NEW PRODUCT PRICES REPORT**

The U.S. Department of Agriculture's National Agricultural Statistical Service (NASS) began publishing weekly prices for butter, nonfat dry milk, and dry whey on October 9, 1998 at 8:30 a.m. (ET). Prices for these three items will be published along with the price for cheddar cheese in a new report entitled "Dairy Products Prices." The new report will provide information on weighted average prices received and aggregated volumes of sales. The October 9 report contained data for the weeks ending September 5 through October 3, 1998. Subsequent weekly reports will have the most recent five weeks of data in each report. The Dairy Products Prices report is based on a survey of manufacturers that sell these specific products on a bulk, wholesale basis. The surveys were begun at the request of the Secretary of Agriculture. The purpose of the report is to provide a statistically defendable price series for cheddar cheese, butter, nonfat dry milk, and dry whey to satisfy industry and USDA needs.

#### **CME APPROVES NEW FUTURES AND OPTIONS**

On October 9 the U.S. Commodity Futures Trading Commission (CFTC) approved the Chicago Mercantile Exchange's (CME) request to trade futures and options contracts based on the value of nonfat dry milk and dry whey. The CME had not set a launch date for the contracts as of October 9.

The dairy contracts will reflect the value of 44,000 pounds of each underlying commodity based on weekly cash prices as calculated by the U.S. Department of Agriculture.




