

#### MARKET SUMMARIES FOR DECEMBER

The December Class III price increased 50 cents from the previous month to \$17.34. The Class II price for December of \$16.34 per hundredweight increased 94 cents from \$15.40 in November. December's Class III-A price decreased \$1.39 from November's level to \$13.48.

**Texas:** Producers who delivered milk to handlers located in Zones 1 and 2 of the Texas Milk Market Order received \$17.85 per hundredweight for deliveries of milk containing 3.5% butterfat. The December price was up 41 cents from November.

Producers delivered a total of 443,176,856 pounds of milk during December. On a daily basis this represents an increase of 4.57 percent from the producer receipts level in November but it represents a decrease of 12.19 percent when compared to the producer receipts level of December 1997.

Producer milk classified as Class I during December amounted to 62.18 percent of total producer receipts. This figure is down from November's 64.80 percent but it is up from 53.42 percent in December 1997. The average butterfat test of producer milk pooled during December 1998 was 3.701 percent.

New Mexico - West Texas: Producers who delivered milk to handlers located in Zone 1 of the New Mexico - West Texas Milk Market Order received \$17.08 per hundredweight for deliveries of milk containing 3.5% butterfat. The December price was up 19 cents from its November level.

Producers delivered a total of 87,563,560 pounds of milk during December. On a daily basis this represents a decrease of 38.69 percent from the producer receipts level in November and it represents a decrease of 52.79 percent when compared to the producer receipts level of December 1997.

Producer milk classified as Class I during December amounted to 61.23 percent of total producer

receipts. This figure is up from 37.47 percent in November and it is up from 29.23 percent in December 1997. The average butterfat test of producer milk pooled during December 1998 was 3.693 percent.

### U.S. EIGHTH CIRCUIT REFUSES CLASS I APPEAL

On November 20, 1998, the full U.S. Eighth Circuit Court of Appeals refused to hear an appeal in the case of the Minnesota Milk Producers Association (MMPA) v. Glickman. MMPA was appealing the August 13 decision of a three-judge panel of the Circuit Court, which found that the Secretary of Agriculture is "within his discretion" to "maintain the current system of pricing Class I milk". A previous District Court decision had declared Class I differentials unenforceable in as many as 18 of 31 Federal milk marketing orders. MMPA now has until February to file an appeal in the U.S. Supreme Court.

#### 1999 SUPPORT PRICE FOR MILK

The U.S. Department of Agriculture's Commodity Credit Corporation (CCC) announced that the support price for milk will be \$9.90 per hundredweight (cwt) during calendar year 1999, effective January 1, 1999. This is a reduction of 15 cents per cwt from the current support level, and is required by the Federal Agriculture Improvement and Reform Act of 1996 (the Act). The Act authorized the Milk Price Support Program through December 31, 1999, at the following support price levels: \$10.35 per cwt during calendar year 1996, \$10.20 per cwt during calendar year 1997, \$10.05 per cwt during calendar year 1998, and \$9.90 per cwt during calendar year 1999.




