

MARKET SUMMARY FOR JANUARY

The Producer Price Differential (P.P.D.) for milk delivered to handlers located in Dallas/Tarrant counties (TX) of the Southwest Milk Market Order was \$3.63 for January. Butterfat price decreased \$0.3638 per pound from \$1.6534 in December to the level of \$1.2896 for January. Protein price increased \$0.5803 cents per pound to \$1.6181 in January from \$1.0378 in December. January's Other Solids price increased \$0.0291 per pound from the previous month to \$0.1120. The Somatic Cell Count adjustment rate factor for January was .00056 per thousand (difference from 350).

For comparison in hundredweights, producers who delivered milk to handlers located in Dallas/Tarrant counties (TX) received a January statistical uniform price of \$13.62 per hundredweight for milk testing 3.5% butterfat, 2.99% true protein, 5.69% other solids and 350,000 SCC. This is an increase of 71 cents in comparison to the statistical blend price of \$12.91 in December.


FEBRUARY 2001

The January Class I price increased \$1.86 cents from \$15.13 in December to the January level of \$16.99. The Class II price for January of \$12.82 per hundredweight decreased \$1.15 from \$13.97 in December. January's Class III price increased 62 cents from \$9.37 in December to \$9.99 in January. The Class IV price decreased \$1.14 from \$13.27 in December to \$12.13 in January.

In January 802 producers delivered a total of 748,007,167 pounds of milk. On a daily basis this represents an increase of 13.00 percent from the producer receipts level in December but it represents a decrease of 7.06 percent when compared to the producer receipts level of January 2000.

Producer milk classified as Class I during January amounted to 47.83 percent of total producer receipts. This figure is down from 49.90 percent in December but it is up from 42.14 percent in January 2000. The average butterfat test of producer milk pooled during January was 3.766 percent, average protein test was 3.114 percent, average other solids test was 5.675 percent and the average somatic cell count was 392,000.




