#### MARKET SUMMARY FOR MARCH

The Producer Price Differential (P.P.D.) for milk delivered to handlers located in Dallas/Tarrant counties (TX) of the Southwest Milk Market Order was \$2.12 for March. Butterfat price decreased \$0.0179 per pound from \$1.3817 in February to the level of \$1.3638 in March. Protein price decreased \$0.2542 per pound from \$2.0884 in February to \$1.8342 in March. March's Other Solids price decreased \$0.0277 per pound from the previous month to \$0.0688. The Somatic Cell Count adjustment rate factor for March was .00060 per thousand (difference from 350).

For comparison in hundredweights, producers who delivered milk to handlers located in Dallas/Tarrant counties (TX) received a February statistical uniform price of \$12.77 per hundredweight for milk testing 3.5% butterfat, 2.99% true protein, 5.69% other solids and 350,000 SCC. This is a decrease of \$0.51 in comparison to the statistical blend price of \$13.28 in February.

The March Class I price decreased 33 cent from


\$14.95 in February to the March level of \$14.62. The Class II price for March of \$12.19 per hundredweight decreased \$0.09 from \$12.28 in February. March's Class III price decreased \$0.98 from \$11.63 in February to \$10.65 in March. The Class IV price decreased \$0.12 from \$11.54 in February to \$11.42 in

March. In March 947 producers delivered a total of 865,829,556 pounds of milk. On a daily basis this represents an increase of 2.90 percent from the producer receipts level in February and it represents an increase of 26.81 percent when compared to the producer receipts level of March 2001.

Producer milk classified as Class I during March amounted to 39.03 percent of total producer receipts. This figure is down from 41.59 percent in February and it is down from 50.87 percent in March 2001. The average butterfat test of producer milk pooled during March was 3.688 percent, average protein test was 3.057 percent, average other solids test was 5.703 percent and the average somatic cell count was 307,000.


