#### MARKET SUMMARY FOR JANUARY

The Producer Price Differential (P.P.D.) for milk delivered to handlers located in Dallas/Tarrant counties (TX) of the Southwest Milk Market Order was \$1.90 for January. Butterfat price decreased \$0.3177 per pound from \$2.0507 in December to the level of \$1.7330 in January. Protein price decreased \$0.3186 per pound from \$2.8486 in December to \$2.5300 in January. January's Other Solids price increased \$0.0041 per pound from \$0.0858 in December to \$0.0899 in January. The Somatic Cell Count adjustment rate factor for January was .00076 per thousand (difference from 350).

For comparison in hundredweights, producers who delivered milk to handlers located in Dallas/Tarrant counties (TX) received a January statistical uniform price of \$16.04 per hundredweight for milk testing 3.5% butterfat, 2.99% true protein, 5.69% other solids and 350,000 SCC. This is an increase of \$0.37 in comparison to the statistical blend price of \$15.67 in December.

The January Class I price increased \$2.22 from \$17.43 in December to the January level of \$19.65. The Class II price for January of \$13.04 per hundredweight decreased \$0.94 from \$13.98 in December. January's Class III price decreased \$2.00 from \$16.14 in December to \$14.14 in January. The Class IV price decreased \$0.90 from \$13.42 in December to \$12.52 in January.

In January 833 producers delivered a total of 797,699,927 pounds of milk. On a daily basis this represents an increase of 26.23 percent from the producer receipts level in December but it represents a decrease of 0.05 percent when compared to the producer receipts level of January 2004.

Producer milk classified as Class I during January amounted to 44.28 percent of total producer receipts. This figure is down from 57.14 percent in December and it is down from 45.26 percent in January 2004. The average butterfat test of producer milk pooled during January was 3.740 percent, average protein test was 3.114 percent, average other solids test was 5.692 percent and the average somatic cell count was 324,000.

#### LEWIS "PUDGE" TORRANCE 1911-2004

Born in Lincoln, Nebraska in May 1911, Lewis spent summers working in his father's butter manufacturing plant, later sold to Fairmont. It was only natural that he should follow in that vocation after his formal education. A week after his high school commencement, he was managing an ice cream plant in Herrington, Kansas.

Torrance's first affiliation with Borden was in 1933 at the Houston plant, where he worked in the financial office, running a comptometer (an early type of cal-



culator.) This was quickly followed by ever-increasing responsibilities at the Oklahoma City, Oklahoma; Houston, Texas; Baton Rouge, Louisiana, Borden plants. After serving in the military Red Cross in the Pacific theater during WWII, Torrance returned to Borden in Houston, then on to Jackson, Mississippi, Baton Rouge, Loui-

siana, and back to Houston as comptroller. Then later he moved to San Francisco, California, as the youngest corporate vice-president. Soon afterward he returned to Texas as Western Manager in Lubbock before returning to Houston as Vice President of the Southern Division, and finally to Columbus, Ohio as Corporate Vice President of Borden and President of Borden's Dairy and Services Division. He was well known for his ability to turn plants around, and turn red ink into black!

Among his many achievements, Torrance was most proud of the many young people he had helped to advance up the Borden ladder in the Southern and Northern Divisions where he had executive responsibilities.

In recognition of his achievements in the Dairy Products Industry, he was honored by the election to the presidencies of; the Southern Association of Food Manufacturers, including the ice cream manufacturers; the Dairy Products Institute of Texas; the Louisiana Dairy Products Association; the Texas Spurs (Retails Grocers' Association). He also served on the Board of Directors and Executive Committee of the Milk Industry Foundation. He retired at the age of 68.

Mr. Torrance is survived by his devoted wife of 64 years, Betty; his sister, Elizabeth; daughter, Sandi; daughter and son-in-law Shan and Ted Mackall; three grandchildren, Cody, Kelley, and Casey; and countless other friends and family across the country.

#### SENATE CONFIRMS JOHANNS AS AGRICULTURE SECRETARY

Secretary of Agriculture-designee and Nebraska Gov. Mike Johanns became the first member of President Bush's second-term cabinet to be confirmed by the Senate.

Johanns, the son of an Iowa dairy farmer, was approved on a voice vote shortly after the president's inauguration. He was sworn in by outgoing Agriculture Secretary Ann Veneman.



Secretary Veneman, a California native who had nearly 20 years of service with USDA, announced that she will become executive director of the United Nations Children's Fund (UNICEF).

Johanns is expected to retain a portion of Veneman's USDA's upper echelon, including chief of staff Dale Moore

and J.B. Penn, an Arkansas native, who is undersecretary for farm and foreign agricultural services, for the time being.

The new secretary grew up on a dairy farm I northeast lowa. He graduated from law school in Nebraska and worked in private practice before being elected to two terms as mayor of Lincoln. In his two terms as governor, Johanns gained a reputation as a fiscal conservative, reducing the size of his office and making other spending cuts.

The Senate Agriculture Committee, along with a new Chairman, Saxby Chambliss (R-GA) will also have some new members on the committee of the 109th Congress. Republicans will hold 11 seats while Democrats will hold nine.

New members of the committee includes Sens. Craig Thomas (R-WY), Rick Santorum (PA), and Ken Salazar (D-CO).

The rest of the Republican committee includes: Chambliss, Richard Lugar (IN), Thad Cochran (MS), Mitch McConnell (KY), Pat Roberts (KS), James Talent (MO), Norm Coleman (MN), Mike Crapo (ID), and Charles Grassley (IA).

Members on the Democratic side are: Ranking Member Tom Harkin (IA), Patrick Leahy (VT), Kent Conrad (ND), Max Baucus (MT), Blanche Lincoln (AR), Debbie Stabenow (MI), Ben Nelson (NE), and Mark Dayton (MN).




