

MARKET SUMMARY FOR DECEMBER

The Producer Price Differential (P.P.D.) for milk delivered to handlers located in Dallas/Tarrant counties (TX) of the Southwest Milk Market Order was \$0.58 for December. Butterfat price decreased \$0.0371 per pound from \$1.3852 in November to the level of \$1.3481 in December. Protein price increased \$0.2005 per pound from \$2.2383 in November to \$2.4388 in December. December's Other Solids price increased \$0.0288 per pound from \$0.2276 in November to \$0.2564 in December. The Somatic Cell Count adjustment rate factor for December was 0.00068 per thousand (difference from 350).

For comparison in hundredweights, producers who delivered milk to handlers located in Dallas/Tarrant counties (TX) received a December statistical uniform price of \$14.05 per hundredweight for milk testing 3.5% butterfat, 2.99% true protein, 5.69% other solids and 350,000 SCC. This is an increase of \$0.22 in comparison to the statistical blend price of \$13.83 in November.


The December Class I price decreased \$0.03 from \$15.40 in November to the December level of \$15.43. The Class II price for December of \$12.55 per hundredweight increased \$0.57 from \$11.98 in November. December's Class III price increased \$0.63 from \$12.84 in November to \$13.47 in December. The Class IV price increased \$0.19 from \$12.11 in November to \$12.30 in December.

In December 765 producers delivered a total of 1,077,095,575 pounds of milk. On a daily basis this represents an increase of 12.40 percent from the producer receipts level in November an it represents an increase of 23.82 percent when compared to the producer receipts level of December 2005.

Producer milk classified as Class I during December amounted to 32.53 percent of total producer receipts. This figure is down from 38.24 percent in November an it is down from 40.75 percent in December 2005. The average butterfat test of producer milk pooled during December was 3.801 percent, average protein test was 3.187 percent, average other solids test was 5.675 percent and the average somatic cell count was 260,000.




