MARKET SUMMARY FOR DECEMBER

The Producer Price Differential (P.P.D.) for milk delivered to handlers located in Dallas/Tarrant counties (TX) of the Southwest Milk Market Order was \$2.56 for December. Butterfat price decreased \$0.4470 per pound from \$2.2422 in November to the level of \$1.7952 in December. Protein price decreased \$0.0275 per pound from \$2.1981 in November to \$2.1706 in December. December's Other Solids price increased \$0.0055 per pound from \$0.1797 in November to \$0.1852 in December. The Somatic Cell Count adjustment rate factor for December was 0.00073 per thousand (difference from 350).

For comparison in hundredweights, producers who delivered milk to handlers located in Dallas/Tarrant counties (TX) received a December statistical uniform price of \$16.39 per hundredweight for milk testing 3.5% butterfat, 2.99% true protein, 5.69% other solids and 350,000 SCC. This is a decrease of \$1.30 in comparison to the statistical uniform price of \$17.69 in November.

The December Class I price decreased \$0.28 from \$20.24 in November to the December level of \$19.96. The Class II price for December of \$15.77 per hundredweight decreased \$1.44 from \$17.21 in November. December's Class III price decreased \$1.61 from \$15.44 in November to \$13.83 in December. The Class IV price decreased \$1.65 from \$16.68 in November to \$15.03 in December.

In December 480 producers delivered a total of 990,136,481 pounds of milk. On a daily basis this represents an increase of 6.35 percent from the producer receipts level in November and it represents an increase of 9.91 percent when compared to the producer receipts level of December 2009.

Producer milk classified as Class I during December amounted to 38.77 percent of total producer receipts. This figure is down from 42.79 percent in November and it is down from 41.12 percent in December 2009. The average butterfat test of producer milk pooled during December was 3.829 percent, average protein test was 3.179 percent, average other solids test was 5.747 percent and the average somatic cell count was 193.000.




