July 2022 Federal Order No. 126

Market Overview

Producers who delivered milk to handlers located in Dallas/Tarrant counties (TX) received a June statistical uniform price of \$26.04 for milk testing 3.5% butterfat, 2.99% true protein, 5.69% other solids and 350,000 SCC. This is an increase in comparison to the statistical uniform price of \$25.85 in May.

The Producer Price Differential (PPD) for milk delivered to handlers located in Dallas/Tarrant counties (TX) of the Southwest Milk Market Order was \$1.71 for June. The June Class I price increased \$0.42 from \$28.45 in May to the June level of \$28.87. The Class II price increased \$0.78 from \$25.87 in May to \$26.65 in June. The Class III price decreased \$0.88 from \$25.21 in May to \$24.33 in June. The Class IV price increased \$0.84 from \$24.99 in May to \$25.83 in June.

In June, 345 producers delivered a total of 1,091,837,677 pounds of milk. On a daily basis, this represents a decrease of 6.95 percent from the producer receipts level in May and an increase of 12.77 percent when compared to the producer receipts level of June 2021.

Producer milk classified as Class I during June amounted to 26.81 percent of total producer receipts. This figure is up from 25.97 percent in May and down from 29.84 percent in June 2021. The average butterfat test of producer milk pooled during June was 3.981 percent, average protein test was 3.219 percent, average other solids test was 5.805 percent, and the average somatic cell count was 183,000.

The June butterfat price increased \$0.2267 from \$3.1056 in May to the June level of \$3.3323. The protein price decreased \$0.4523 from \$3.8696 in May to \$3.4173 in June. The other solids price decreased \$0.0562 from \$0.4857 in May to \$0.4295 in June. The somatic cell adjustment rate in June was 0.00117 per cwt.

June 2022 Pool Summary


- ◆ The Statistical Uniform Price for the Southwest Order in June 2022 is \$26.04 with a PPD of \$1.71
- ◆ 1,092 million pounds were pooled in June. This is down 1.39 percent on a daily basis from May 2022
- → 345 producers pooled their milk; this is down from 406 in May
- → Class I milk accounted for 26.81 percent of all receipts, up from 25.97 in May

Texas Dairy Production

In June, Texas dairy production totaled 1,367 million pounds. This is a 7.01 percent increase relative to June 2021 and a 19.3 percent increase from the June five year average (2017-2021). The June average butterfat for Texas production is 4.12 percent, the average protein is 3.28 percent, and the average other solids at 5.81 percent. The average somatic cell count is at 186,000.





New Mexico Dairy Production

In June, New Mexico dairy production totaled 583 million pounds. This is a 11.60 percent decrease relative to June 2021 and a 13.70 percent decrease from the June five year average (2017-2021). The June average butterfat is 3.74 percent, the average protein is 3.12 percent, and the average other solids at 5.81 percent. The average somatic cell count is at 165,000.


