

MARKET SUMMARY FOR SEPTEMBER

The Producer Price Differential (P.P.D.) for milk delivered to handlers located in Dallas/Tarrant counties (TX) of the Southwest Milk Market Order was \$1.03 for September. Butterfat price increased \$0.1413 per pound from \$1.7941 in August to the level of \$1.9354 in September. Protein price increased \$0.0768 per pound from \$2.4663 in August to \$2.5431 in September. September's Other Solids price decreased \$0.0087 per pound from \$0.0676 in August to \$0.0589 in September. The Somatic Cell Count adjustment rate factor for September was .00079 per thousand (difference from 350).

For comparison in hundredweights, producers who delivered milk to handlers located in Dallas/Tarrant counties (TX) received a September statistical uniform price of \$15.75 per hundredweight for milk testing 3.5% butterfat, 2.99% true protein, 5.69% other solids and 350,000 SCC. This is an increase of \$0.26 in comparison to the statistical blend price of \$15.49 in August.

The September Class I price decreased \$0.68 from \$17.62 in August to the September level of \$16.94. The Class II price for September of \$13.66 per hundredweight increased \$0.53 from \$13.13 in August. September's Class III price increased \$0.68 from \$14.04 in August to \$14.72 in September. The Class IV price increased \$0.54 from \$12.46 in August to \$13.00 in September.

In September 777 producers delivered a total of 743,907,078 pounds of milk. On a daily basis this represents a decrease of 1.19 percent from the producer receipts level in August but it represents an increase of 40.14 percent when compared to the producer receipts level of September 2003.

Producer milk classified as Class I during September amounted to 47.88 percent of total producer receipts. This figure is up from 45.62 percent in August but it is down from 65.42 percent in September 2003. The average butterfat test of producer milk pooled during September was 3.545 percent, average protein test was 3.067 percent, average other solids test was 5.692 percent and the average somatic cell count was 307.000.

COOPERATIVES WORKING TOGETHER OPENS BIDDING PERIOD FOR SECOND DAIRY HERD RETIREMENT PROGRAM

In response to increasing cow numbers and declining milk price futures, on October 1st, the farmer-led and farmer-funded CWT program opened a one-month bidding period for a second program to retire entire dairy herds. Until October 30th, CWT will be accepting bids from interested dairy farmers willing to sell their milking herds to slaughter. Producers who wish to bid must be paying the five-cent per hundredweight CWT membership assessment, either through their cooperative, or directly.

This year's program has been targeted to remove 870 million pounds of milk, 260 million pounds more than was removed during last year's herd retirement. To achieve this goal, CWT management expects to retire individual herds totaling 49,000 cows, nearly 50 percent more than in the autumn of 2003. Asked about this marked increase in the herd retirement target, Walt Wosje, CWT's Chief Operating Officer, explained:

"We were able to remove more total milk volume than we had anticipated last year, for less money than we budgeted. Interest in the program was also greater than we anticipated, as we received over 2,000 bids – of which we were only able to accept about 300. So even though milk prices have been much better this year, we believe there's still interest among producers in a second retirement program."

It has been estimated that CWT's last round of activities resulted in a 59-cent per hundredweight increase in the monthly average All-Milk-Price between October 2003 and September 2004.

"This past winter and spring, we saw what was akin to a perfect storm of factors pulling together to raise milk prices from their record lows. Between CWT's activities, the Canadian border being closed, and increased milk demand, milk prices really rebounded quickly. Unfortunately, that illustrates our concern about the market's volatility. CWT activities, like this herd retirement and our export assistance program, are meant to not only strengthen milk prices but also stabilize them. We can't simply depend on market factors. Our increased targets this year reflect our understanding that we won't necessarily have all the other factors working with us this time."

The herd retirement will again operate under regional safeguard limits to guarantee that milk production capacity reductions in any one area do not nega-

tively impact local supplies. While the safeguard levels are strictest in areas where supply hasn't grown rapidly, such as the Northeast and Upper Midwest, larger safeguard ceilings have been set for regions that have experienced greater supply growth, such as the West and Southwest.

The CWT Export Assistance program continues to accept bids for both cheese and butter at the target price levels of \$1.40 per pound and \$1.30 per pound, respectively.

Cooperatives Working Together is being funded by dairy cooperatives and individual dairy farmers, who are contributing 5 cents per hundredweight assessment on their milk production from July 2004 through June 2005. The money raised by CWT's assessment will be apportioned among two supply reduction programs to improve farm-level milk prices. In its first year, CWT removed approximately 700 million pounds milk equivalent through three reduction activities, resulting in an increase in the all-milk price of 59 cents per hundredweight from Oct. 2003 through Sept. 2004.

USDA ANNOUNCES FINAL DECISION TO AMEND ALL FEDERAL MILK MARKETING ORDERS

The U. S. Department of Agriculture announced a final decision that permanently adopts amendments to the classification of milk provisions in all 10 Federal milk marketing orders. These provisions were previously implemented on an interim basis. This decision is based on testimony and evidence from a public hearing held Oct. 21, 2003, in Alexandria, Va.

This decision adopts changes that reclassify milk used to produce evaporated milk or sweetened condensed milk in consumer-type packages from Class III to Class IV. A proposal to classify monthly bulk milk ending inventories to the lowest-priced class of Class III or Class IV is not adopted in this final decision.

The final decision will be published in the Sept. 24 Federal Register. USDA will conduct a vote within 30 days to determine whether dairy farmers approve the proposed amended orders. If approved, a final rule will follow to implement these changes.




